The number of RSUs was determined by dividing \$80,000 by \$48.19, the closing price of the Issuer's Common Stock on the New York Stock Exchange on the day before the grant.
 (2) The 15,000 shares are held by ALG International, LLC in which Mr. Goldstein has a 33.3% interest.
