- (4) one, two and three years. The PBRs earned for each performance period will vest at the end of the three-year cycle ending on December 31, 2014. PBRs that do not vest will be cancelled.
 - (5) The PBRs represent a contingent right to receive that number of shares of Ryder common stock equal to 25% to 125% of the number of PBRs based on the Company achieving certain threshold, target or maximum performance goals.
