(ii) MCM owned directly no shares of Common Stock. By reason of its position as investment advisor, MCM may be deemed to beneficially own the 402,578 shares of Common Stock which are held of record by clients of MCM, constituting approximately 8.45% of the shares outstanding.

(iii) Mr. Maltese directly owned no shares of Common Stock. By reason of his position as Managing Member of MCM, Mr. Maltese may be deemed to beneficially own 402,578 shares of Common Stock, constituting approximately 8.45% of the shares outstanding.
