(1) On March 2, 2015, the reporting person was granted an award of 18,760 stock appreciation rights ("SARs"). The performance criteria was met in 2015, resulting in the vesting of 3,752 SARs.

(2) On April 30, 2014, the reporting person was granted an award of 15,396 SARs. The amount and timing of the vesting of these SARs is dependent upon the Company's achievement of certain performance criteria for each of fiscal 2014, 2015 and 2016. The performance criteria was met in 2015, resulting in the vesting of 3,080 SARs.
