The ESPP shares were purchased following the Reporting Person's last Section 16 filing. Under the ESPP 897.99 shares were acquired on September 8, 2016 at a transaction price of \$13.92 per share and 960.06 shares were acquired on December 8, 2016 at a transaction price of \$13.02. The ESPP provides for the purchase of fractional shares. The numbers reported herein are rounded to the nearest whole number.
