- (1) The stock appreciation rights vest and are exercisable as to 25% of the total on June 5, 2010 and 25% on June 5 of each of the following three years.
- (2) The number of shares underlying stock appreciation rights will be determined at the time of exercise by calculating the difference between the closing price of Cascade common stock on the date of exercise and the base price of the stock appreciation rights established at the time of grant (see column 2), multiplying that figure by the number of stock appreciation rights held by the reporting person, and then dividing the product by the closing price of Cascade common stock on the date of exercise.
