Shares purchased upon exercise of such options are subject to sale restrictions until the reporting person terminates employment with the Company as follows: 28% of shares purchased may be sold on or after December 1, 2006. Thereafter, an additional 3% of shares purchased per month for the remaining 24 months may be sold. Options expire ten years from grant date.
 - (3) Options have a 3 year vesting schedule: 28% one year from grant date and 3% for each of the remaining 24 months.
 - (4) Reporting person will pay option price at time of exercise.
