holding company/control person in accordance with Section

Item 4. Ownership

The information in items 1 and 5 through 11 on the cover page(s) on  
Schedule 13G is hereby incorporated by reference.

Janus Henderson has an indirect 97.11% ownership stake in Intech  
Investment Management LLC ("Intech") and a 100% ownership stake in Janus  
Capital Management LLC ("Janus Capital"), Perkins Investment Management  
LLC ("Perkins"), Geneva Capital Management LLC ("Geneva"), Henderson  
Global Investors Limited ("HGIL"), Janus Henderson Investors Australia  
Institutional Funds Management Limited ("HGIAIFML") and Henderson Global  
Investors North America Inc ("HGINA"), (each an "Asset Manager" and  
collectively as the "Asset Managers"). Due to the above ownership  
structure, holdings for the Asset Managers are aggregated for purposes  
of this filing. Each Asset Manager is an investment adviser registered  
or authorized in its relevant jurisdiction and each furnishing  
investment advice to various fund, individual and/or institutional  
clients (collectively referred to herein as "Managed Portfolios").

As a result of its role as investment adviser or sub-adviser to the  
Managed Portfolios, Janus Capital may be deemed to be the beneficial  
owner of 7,312,454 shares or 8.6% of the shares outstanding of Steris  
Common Stock held by such Managed Portfolios. However, Janus Capital  
does not have the right to receive any dividends from, or the proceeds  
from the sale of, the securities held in the Managed Portfolios and  
disclaims any ownership associated with such rights.

As a result of its role as investment adviser or sub-adviser to the  
Managed Portfolios, Perkins may be deemed to be the beneficial owner of

90 shares or 0.0% of the shares outstanding of Steris Common Stock held by such Managed Portfolios. However, Perkins does not have the right to receive any dividends from, or the proceeds from the sale of, the securities held in the Managed Portfolios and disclaims any ownership associated with such rights.

As a result of its role as investment adviser or sub-adviser to the Managed Portfolios, Intech may be deemed to be the beneficial owner of 108,900 shares or 0.1% of the shares outstanding of Steris Common Stock held by such Managed Portfolios. However, Intech does not have the right to receive any dividends from, or the proceeds from the sale of, the securities held in the Managed Portfolios and disclaims any ownership associated with such rights.

As a result of its role as investment adviser or sub-adviser to the Managed Portfolios, Geneva may be deemed to be the beneficial owner of 569,929 shares or 0.7% of the shares outstanding of Steris Common Stock held by such Managed Portfolios. However, Geneva does not have the right to receive any dividends from, or the proceeds from the sale of, the securities held in the Managed Portfolios and disclaims any ownership associated with such rights.

### Item 6. Ownership of More than Five Percent on Behalf of Another Person

The Managed Portfolios, set forth in Item 4 above, have the right to receive all dividends from, and the proceeds from the sale of, the securities held in their respective accounts.

The interest of any one such person does not exceed 5% of the class of securities.

These shares were acquired in the ordinary course of business, and not with the purpose of changing or influencing control of the Issuer.

### Item 7. Identification and Classification of the Subsidiary Which Acquired the Security Being Reported on by the Parent Holding Company

Janus Capital, Intech, Perkins, Geneva, HGIL, HGIAIFML and HGINA are indirect subsidiaries of Janus Henderson and are registered investment advisers furnishing investment advice to Managed Portfolios.
