 - (1) Includes 16,542 restricted stock units (RSUs) mandatorily deferred by the Company from Mr. Derechin's annual discretionary bonus, plus 4,135 RSUs granted to Mr. Derechin as a Company match on his mandatory bonus deferral. These RSUs will generally vest ratably over four years. Also includes 9,089 RSUs voluntarily deferred by Mr. Derechin from his annual discretionary bonus, plus 2,272 RSUs granted to Mr. Derechin as a Company match on his voluntary bonus deferral. These RSUs will generally be delivered on the third anniversary of grant.
 - (2) Represents the withholding by the Company of a sufficient number of shares of common stock to satisfy Mr. Derechin's tax obligation upon the vesting of 4,973 previously reported RSUs.
