**Payment of interest on capital**

Rio de Janeiro, December 22<sup>nd</sup>, 2011 – Petróleo Brasileiro S.A. - Petrobras, informs that, the Board of Directors approved today the fourth advanced payment of interest on own capital (IOC), in accordance with Brazilian legislation.

The amount of R\$ 2,609 million to be paid, corresponding to a gross value of R\$ 0.20 per common and preferred shares, is being accrued in our Financial Statements on December 31<sup>st</sup>, 2011. Payment date will be no later than March 30<sup>th</sup>, 2012. The record date will be January 2<sup>nd</sup>, 2012, in Brazil.

The shares will be negotiated ex-interest on capital from the first business day after the record date.

This IOC restated at the Brazilian Interest Rate – SELIC, and the shareholders will be entitled to receive the payment restated by SELIC rate from December 31, 2011 to the effective payment date.
