The Compensation Committee of the Board of Directors granted the award at a regular meeting duly called and held on December 3, 2012. He therefore may be deemed to have acquired 12,265 Holding Units. These Holding Units are held in a rabbi trust under AllianceBernstein's incentive compensation award program until they vest and are distributed to the Reporting Person.
