**Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.**

On November 20, 2006, the Board of Directors elected Mr. Jack Guynn as a Director of the Company to fill a vacancy resulting from an increase in the number of directors from twelve to thirteen.
