- Pursuant to an amendment to the retirement policy governing the restricted stock units ("RSUs") of Lazard Ltd (the "Company"), the reporting person met the requirements to receive all of the shares underlying his RSUs that were granted prior to December 31, 2009. The
- (1) amendment provided that 46% of the reporting person's shares could be sold or withheld by the Company to pay applicable taxes and the remainder would be subject to certain restrictions on transfer, and other covenants, in accordance with the vesting schedule of the prior awards.
  - (2) The shares of Class A common stock were acquired upon the conversion Restricted Stock Units.
  - (3) Shares withheld by the Company to cover estimated taxes.
  - (4) Each Restricted Stock Unit represented a contingent right to receive one share of Class A common stock of Lazard Ltd.
