- (1) Each restricted stock unit represents a contingent right to acquire one share of DY common stock, par value \$0.33 1/3 per share.
- (2) The restricted stock units vest in four substantially equal annual installments beginning December 14, 2017.
- (3) No consideration was paid for the restricted stock units.

These shares were awarded in settlement of the restricted stock units that vested on December 14, 2016 based upon the satisfaction of the following pre-established performance measures (i) operating earnings and (ii) the ratio of operating cash flow to net income, in each case before certain items. The shares reported include 709 shares that vested in connection with the satisfaction of the performance measures described in the preceding three year performance period.

- (5) Withholding of common stock for the payment of tax liability incident to the vesting of restricted stock units.
