## Explanation of Responses:

- (1) Includes 15,000 shares of a restricted stock grant. Fifty percent vests in two years on January 3, 2008 and the balance after four years on January 3, 2010.
- (2) Includes 24,000 shares of a restricted stock grant. 7,500 vests January 3, 2008 and the balance after four years on January 3, 2010. 4,500 vests on November 1, 2009 and the balance on November 1, 2011.
- (3) The number of underlying securities is based on the stock fund balance on October 31, 2007. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a October 31, 2007, stock fund price of \$43.72 per share.
- (4) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination of employment with the company and may be transferred by the reporting person into an alternative investment account at any time.
- (5) The phantom stock units were accrued under the Johnson Controls Annual Incentive Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.
- (6) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock Grant.
- (7) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
