Offering of Unsecured Convertible Note

On January 31, 2018, Ascent Solar Technologies, Inc., a Delaware corporation (the "Company") sold and issued to BayBridge Capital Fund LP ("Investor") a \$200,000 aggregate principal amount unsecured convertible note (the "Note") in exchange for \$177,500 of gross proceeds.

Terms of the Note

The Note will mature on December 29, 2018. Principal and interest on the Note will be payable in a lump sum on December 29, 2018.

The Note will bear interest at a rate of 12% per annum.

The Note contains standard and customary events of default including but not limited to: (i) failure to make payments when due under the Note, and (ii) bankruptcy or insolvency of the Company.

The Note is not convertible.

The Note is not secured.
