The annual retainer and other fees are payable quarterly in arrears.
- (1) Each DSU is the economic equivalent of one share of the Company's common stock. The DSUs become payable, in common stock, or at the Company's election, cash, at the earlier of the reporting person's separation from service or a change in control. DSUs earn dividend equivalents when dividends are declared on the Company's common stock.
  - (2) The number of DSUs received was calculated based on \$47.07, which was the closing price of the Company's common stock on the date of grant.
