On November 17, 2017, the Special Meeting of Stockholders of Discovery Communications, Inc. (the “Company”) was held at 850 Third Avenue, New York, New York 10022.

Stockholders approved, the issuance of the Company’s Series C Common stock, par value \$0.01 per share, to Scripps Networks Interactive, Inc. (“Scripps”) shareholders as consideration in the merger contemplated by the Agreement and Plan of Merger, dated as of July 30, 2017, as it may be amended from time to time, among the Company, Scripps and Skylight Merger Sub, Inc., a wholly-owned subsidiary of the Company (the "Proposal").
