(1) On January 29, 2016, Mr. Betz was granted an option to purchase 64,815 shares of common stock of Applied Minerals, Inc. This grant is a component of the compensation Mr. Betz will receive for serving as a Director of the Company for the 2016 calendar year. The exercise price of the option is \$0.28 per share. The term is 10 years. 50% of the option vests on the first anniversary date of the grant and the remaining 50% vests on the second anniversary date of the grant.
