- This represents the difference between the number of SARs exercised (25,000) and the number of shares issued as a result of the exercise (10,700). The number of shares to be issued under a SAR exercise is determined by multiplying the number of SARs being exercised by the difference between the FMV on the date immediately prior to the date the SAR is exercised (\$10.77) and the base price (\$6.16).

Therefore, the number of underlying shares of common stock that may be received upon exercise cannot exceed 1/2 of the number of stock appreciation rights granted.
