(1) Award of restricted share units, which represent the right to receive shares of common stock on a one-to-one basis upon vesting, which is generally three years from the date of grant, subject to terms and conditions. Prior awards of restricted stock units, which have different vesting provisions, have been reported in Table II.

(2) Includes 16,423 shares of restricted stock held by the issuer to implement restrictions on transfer unless and until certain conditions are met and the 7,960 restricted share units being reported as awarded.
