(1) Shares delivered as the redemption price for Accenture SCA Class I common shares pursuant to the exchange of such shares by the Reporting Person in accordance with Article 7 of the Articles of Association of Accenture SCA.

Accenture SCA is a subsidiary of Accenture plc. Subject to certain contractual restrictions, Accenture SCA is obligated, at the option of the Reporting Person, to redeem any outstanding Accenture SCA Class I common shares at a redemption price per share generally equal to the market price of an Accenture plc Class A ordinary share at the time of redemption, subject to an adjustment. Accenture SCA may pay the redemption price with cash or by delivery of Accenture plc Class A ordinary shares. Accenture SCA elected to pay the redemption price for this transaction by delivering Accenture plc Class A ordinary shares.

(3) Planned disposition of Accenture plc Class A ordinary shares pursuant to a Rule 10b5-1 Trading Plan.

The transaction was executed in multiple trades at prices ranging from \$87.21 to \$88.10. The price reported above reflects the weighted average sale price. The reporting person hereby undertakes to provide upon request to the SEC staff, the issuer or a security holder of the issuer full information regarding the number of shares and prices at which the transaction was effected.
