Restricted Stock Units ("RSUs") were awarded on February 13, 2014, pursuant to the Company's 2009 Long-Term Incentive Plan (the (1) "GMLTIP"). Two-thirds of the RSUs will vest on February 13, 2016 and the remaining one-third will vest on February 13, 2017. Each RSU represents a right to receive one share of the Company's common stock upon settlement. RSUs will be settled when they vest.

(2) The Company has determined that 25% of this award will not vest because the terms set forth in the GMLTIP will not be satisfied.

(3) These RSUs will vest on February 13, 2017 provided that the reporting person is employed by the Company on the vesting date.
