The Compensation Committee determined on January 14, 2015 that the number of TSR units earned was 150% of the target. Upon this determination, the TSR units vested immediately. Each TSR unit represented a contingent right to receive one share of the Issuer's Common Stock, based on the percentile ranking of the Issuer's total stockholder return among the total stockholder returns for the stocks comprising a group of pre-selected peer companies over the

three-year performance period.
