The restrictions lapsed on 1/3 of the vesting units (34,130 and 45,765 shares, respectively). Mr. Radford elected to have Hecla Mining Company withhold 35,911 shares to cover his tax liability.
  - (2) Total consists of 421,634 shares held directly and 263,615 unvested restricted stock units.
