(1) The Reporting Person and Nelson Peltz, the Chairman and CEO and a director of Triarc Companies, Inc. ("Triarc") collectively made a gift of 50 shares of Triarc's Class B Common Stock, Series 1 ("Class B Stock"), to an unaffiliated third-party. Shares already owned by the Reporting Person were used to make the gift. The reported sale transaction represents the reimbursement by Mr. Peltz to the Reporting Person of the value of one-half of the gift (25 shares) at a price per share equal to the closing price on the date of the gift.
