- (1) This amended form 4 is being filed to correctly reflect the reporting person's direct ownership of shares of SEI Investments Company ("SEI") common stock, which ownership was over-reported due to an inadvertent mathematical error by 258,794 shares. The reporting person's direct ownership of shares of SEI following the transactions reported on the original form 4 should have been reported as 16,346,196 shares, instead of 16,635,080 as a result of and after taking into account (i) such 558,794 shares inadvertently over-reported by the reporting person on the original form 4 and (ii) 30,090 shares inadvertently over-reported by the reporting person on a form 4 originally filed on August 5, 2008 and amended on the date of this report.
- (2) The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$14.85 to \$15.58, inclusive. The reporting person undertakes to provide to SEI, any security holder of SEI, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the ranges set forth in footnote (2) of this form 4.
