The six months ended March 31, 2005 versus 2004 shows a net revenue increase from \$0 to approximately \$4.9 million. For the six months ended March 31, 2005 the net loss was approximately \$934,000 versus a net loss of \$1,344,000 for the 6 months ended March 31, 2004. The above changes reflect the registrant's acquisition of Gulfgate Equipment, Inc. and Bott Equipment Company, Inc. in October 2004.
