- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 388 units were acquired at prices ranging from \$11.94 to \$15.38. These transactions are exempt under rule 16a-11.
- (2) During the fiscal year under a broker administered distribution reinvestment plan, 18 units were acquired at a price of \$14.66. These transactions are exempt under rule 16a-11.
- (3) Each phantom unit is the economic equivalent of one limited partner unit in Cedar Fair, L.P.
- (4) These awards vest in two equal installments on March 1, 2011 and 2012, respectively, assuming the grantee continues to be employed with the Company.
- (5) Options vest at a rate of 20% per year on each anniversary date, beginning on March 7, 2001.
- (6) Options vest at a rate of 20% per year on each anniversary date, beginning on March 7, 2002.
- (7) Options vest at a rate of 20% per year on each anniversary date, beginning on November 7, 2003.
- (8) Options vest at a rate of 20% per year on each anniversary date, beginning on November 6, 2004.
