Item 8.01 Other Events

Edison Mission Energy ("EME"), a subsidiary of Edison International, has entered into a Purchase Agreement, dated as of August 17, 2005, to sell its aggregate 80% interest in the Doga Project ("Doga Project") to EME's co-investor in the Doga Project, Doga Enerji Yatirim Isletme ve Ticaret Limited ("Doga Enerji"). Doga Enerji will acquire an additional 30% interest in the Doga Project, and The Kansai Electric Power Co., Ltd. ("Kansai") will acquire a 50% interest in the Doga Project. The Doga Project is a 180 megawatt gas-fired cogeneration plant located in Istanbul, Turkey. The terms and conditions of the Purchase Agreement, including the purchase price, are upon and are substantially similar to those established in the auction process conducted in the second quarter of 2005 for a portfolio of international energy assets. Completion of the sale is subject to the satisfaction of certain closing conditions, including obtaining the consent of a majority of the project's lenders. The sale is expected to close in the fourth quarter of 2005.
