(1) Each Restricted Stock Unit represents a contingent right to receive one share of Rentrak common stock. The RSUs will vest, if at all, upon satisfaction of specified performance goals which include trading-price targets for Rentrak's common stock ranging from \$20 to \$40 per share for 65 consecutive trading days during the period ending June 15, 2013, in addition to certain other specified events. For the 65 trading-day period ended July 21, 2010, 2,071 RSUs vested upon satisfaction of the \$21 share price target.
