Michael P. Connors was a member of Oenoke Partners, LLC ("Oenoke") and owned twenty-five percent of the outstanding membership interests. Oenoke held 7,410,937 shares of common stock and 6,500,000 shares of common stock underlying warrants. Pursuant to a Plan of Liquidation and Dissolution, adopted on December 17, 2008, Oenoke dissolved and distributed its shares of common stock and warrants pro rata to its four members who now hold

the common stock and warrants directly. On November 12, 2009, Mr. Connors purchased 315,457 shares of common stock.
