Because of his position as the President and sole shareholder of Scepter, which is the sole general partner of Amalgamated, Raynor may, pursuant to Rule 13d-3 of the Act, be deemed to be the beneficial owner of 3,898,558 shares of the Stock, which constitutes approximately 7.4% of the outstanding shares of the Stock.
