This Amendment No. 1 (this "Amendment") amends the statement on Schedule 13G filed on October 20, 2009 (the "Original Schedule 13G" and the Original Schedule 13G as amended, the "Schedule 13G"), with respect to the shares of Common Stock, \$0.01 par value per share (the "Common Stock"), of Photronics, Inc., a Connecticut corporation (the "Company").
