("International Advisors" and collectively with Elliott Associates and Elliott International, the "Reporting Persons"). Elliott Advisors GP LLC, a Delaware limited liability company ("Elliott Advisors"), which is controlled by Paul E. Singer ("Singer"), Elliott Capital Advisors, L.P., a Delaware limited partnership ("Capital Advisors"), which is controlled by Singer, and Elliott Special GP, LLC, a Delaware limited liability company ("Special GP"), which is controlled by Singer, are the general partners of Elliott Associates. Hambledon, Inc. ("Hambledon"), which is also controlled by Singer, is the sole general partner of Elliott International. International Advisors is the investment manager for Elliott International. International Advisors expressly disclaims equitable ownership of and pecuniary interest in any shares of Common Stock.

Elliott Associates individually beneficially owns 4,516,293 shares of Common Stock, including 1,011,883 shares of Common Stock underlying notational principal amount derivative agreements in the form of physically settled swaps (the "Physical Derivative Agreements"), and including 274,711 shares of Common Stock through The Liverpool Limited Partnership, a Bermuda limited partnership that is a wholly-owned subsidiary of Elliott Associates ("Liverpool").

Elliott International and International Advisors together beneficially own the 9,597,123 shares of Common Stock held by Elliott International, including 2,150,252 shares of Common Stock underlying Physical Derivative Agreements.

Elliott Associates, Elliott International and International Advisors together beneficially own an aggregate of 14,113,416 shares of Common Stock, including 3,162,135 shares of Common Stock underlying Physical Derivative Agreements.

(b) Percent of class:

The aggregate percentage of shares of Common Stock reported owned by each person named herein is based upon 288,028,893 shares of Common Stock outstanding, which is the total number of shares of Common Stock outstanding as of February 23, 2018 as reported in the Issuer's Annual Report on Form 10-K for the fiscal year ended December 31, 2017 filed with the Securities and Exchange Commission on February 28, 2018.

Elliott Associates beneficially owns approximately 1.6% of the outstanding shares of Common Stock.

Elliott International and International Advisors beneficially owns approximately 3.3% of the outstanding shares of Common Stock.

Elliott Associates, Elliott International and International Advisors' aggregate beneficial ownership constituted approximately 4.9% of the outstanding shares of Common Stock.
