("Institutional") is the holder of 155,931 Shares and certain private investment funds (the "Funds") in the aggregate are the holders of 129,468 Shares. Stephen Feinberg possesses sole power to vote and direct the disposition of all securities of the Company owned by each of Cerberus, International, Institutional and the Funds. Thus, as of November 16, 2004, for the purposes of Reg. Section 240.13d-3, Stephen Feinberg is deemed to beneficially own 860,321 Shares, or 13.3% of the Shares deemed issued and outstanding as of that date.

Based upon information set forth in the Company's Quarterly Report on Form 10-Q for the quarterly period ended September 30, 2004, as of November 5, 2004 there were issued and outstanding 6,491,164 Shares. As of November 16,

2004, Cerberus is the holder of 162,171 Shares, International is the holder of 412,751 Shares, Institutional is the holder of 155,931 Shares and the Funds in the aggregate are the holders of 129,468 Shares. Stephen Feinberg possesses sole power to vote and direct the disposition of all securities of the Company owned by each of Cerberus, International, Institutional and the Funds. Thus, as of November 16, 2004, for the purposes of Reg. Section 240.13d-3, Stephen Feinberg is deemed to beneficially own 860,321 Shares, or 13.3% of the Shares deemed issued and outstanding as of that date.

The only transactions in Shares, or securities convertible into, exercisable for or exchangeable for Shares, by Mr. Feinberg or any person or entity controlled by him or any person or entity for which he possesses voting or investment control over the securities thereof, since the filing of the Schedule 13D Amendment No. 2 by Mr. Feinberg dated as of November 9, 2004 were the November 16, 2004 sales of 29,810, 75,800, 28,620 and 23,770 Shares by Cerberus, International, Institutional and the Funds, respectively, at a sale price of \$18.12 per Share (each of which was effected in an ordinary brokerage transaction).
