On March 18, 2009, the issuer cancelled, pursuant to the issuer's option exchange program, an option granted to the reporting person on  
(2) December 13, 2006, and in exchange, the issuer granted a replacement option for 850,000 shares to the reporting person. The new option has an exercise price of \$2.76, which is equal to the closing price of the underlying stock on the grant date.
