- (1) This Form 4 is being filed by Perceptive Life Science Master Fund Ltd. (the "Master Fund"), Perceptive Advisors LLC (the "Advisor") and Joseph Edelman. The Advisor serves as investment manager to the Master Fund and several managed accounts (each a "managed account"). Mr. Edelman is the managing member of the Advisor.
- (2) This transaction represents shares tendered in the initial tender offer commenced with respect to the Issuer's shares and related change in control of the Issuer at a price of \$4.50 per share plus contractual rights to receive up to an additional \$3.00 per share in contingent cash consideration payments.
- (3) This amount reflects the amount of securities held by the Master Fund and the managed accounts immediately following the transaction requiring the filing of this statement. In accordance with Instruction 5(b)(iv) of Form 4, the entire amount of the Issuer's securities held by the Master Fund and the managed accounts is reported herein. Each of Mr. Edelman and the Advisor disclaims, for purposes of Section 16 of the Securities Exchange Act of 1934, beneficial ownership of such securities, except to the extent of his/its indirect pecuniary interest therein, and this report shall not be deemed an admission that Mr. Edelman or the Advisor is the beneficial owner of such securities for purposes of Section 16 or for any other purposes.
