Anticipated Impact of Cessation of Program with a Foreign Customer on Elbit Systems' 2011 Fourth Quarter Net Profit

Haifa, Israel, February 10, 2012 – Elbit Systems Ltd. (NASDAQ and TASE: ESLT) (the “Company”), announced today, further to its announcement of December 22, 2011, the anticipated impact on the Company’s 2011 fourth quarter net profit as a result of the cessation of a program with a foreign customer (the “Program”). The Company expects that as a result of the cessation of the Program the Company’s 2011 fourth quarter net profit will be reduced by approximately \$60 to \$65 million. This amount is a result of write-off of inventories as well as other anticipated costs resulting from the cessation. The Company is currently in discussions with the Israeli Ministry of Defense regarding arrangements with respect to claims of the Company as a result of cessation of the Program.

The Company expects to announce final financial results for the fourth quarter and year end of 2011 during March 2012.
