Turkcell management decided that, according to the Interconnection Settlement Agreement dated December 24, 2004, signed between Turkcell and Turk Telekom the principal amount of the total debt that Turkcell owes to Turk Telekom for the year 2006 amounting to approximately TRY 286.9 million (equivalent to \$213.6 million as of December 21, 2005) shall be paid until the end of 2005 according to early payment option stated in the agreement.
