#### Introductory Statement

This Amendment No. 5 (this “Amendment”) amends the Schedule 13D initially filed on August 6, 2010 (the “Original Filing”), relating to the common shares, par value \$0.01, of Everest Re Group, Ltd. (“Group” or the “Issuer”). Information reported in the Original Filing remains in effect except to the extent that it is amended or superseded by information contained in this Amendment.

#### Item 4. Purpose of Transaction.

The disclosure in Item 4 of this Schedule 13D is hereby amended and supplemented by adding the following statement after the final paragraph thereof:

Everest Reinsurance Holdings, Inc. (“Holdings”), an indirect wholly-owned subsidiary of Group, has not repurchased any additional Common Shares of Group since March 8, 2011.

However, due to Group’s continued repurchases of its own Common Shares through open market transactions pursuant to Group’s authorized share repurchase program, Holdings percentage ownership interest of Group Common Shares has increased to 17.1%.

#### Item 5. Interest in Securities of the Issuer.

The disclosure in Item 5 of this Schedule 13D is hereby amended and supplemented by adding the following statement after the final paragraph thereof:

As of February 19, 2014, Group had 56,775,668 Common Shares outstanding (net of Treasury shares repurchased) of which Holdings owns 9,719,971, or 17.1%, of the outstanding Common Shares. However, according to Group’s bye-laws, the total voting power of any shareholder owning more than 9.9% of the common shares will be reduced to 9.9% of the total voting power of the common shares.
