Includes 248,316 shares of common stock subject to a forward contract pursuant to the CAP Plan with The Bear Stearns Companies Inc. entered into by the Reporting Person on September 3, 2002.**

**(2) On September 3, 2002, the Reporting Person entered into a forward contract pursuant to the CAP Plan with The Bear Stearns Companies Inc. (BSC) in which the Reporting Person agreed to sell up to, and including, 248,316 common shares of BSC issuable upon settlement of CAP Units pursuant to the CAP Plan to BSC. The forward contract settled on November 26, 2002. On November 26, 2002, the Reporting Person delivered to BSC 227,623 common shares of BSC in settlement of its obligation under the forward contract at a purchase price of \$60.96 per share.**
