The purpose of this Amendment No. 7 to the previously filed Schedule 13D is to report that the ownership of Ugland Nordic Shipping ASA ("Ugland") (the "Reporting Person") in the Common Shares, \$.01 par value (the "Shares"), of Nordic American Tanker Shipping Limited (the "Issuer") has decreased by more than 1% of the total outstanding Shares since the date of the last Amendment. The ownership of Ugland has decreased from 14.41% to 11.85% of the total outstanding Shares.

Item 1. Security and Issuer

### Item 2. Identity and Background

This statement is being filed on behalf of Ugland, a Norwegian shipping company. Herbjorn Hansson is the President and Chief Executive Officer of Ugland. The address for Ugland is Thor Dahls gt.1-3, P.O. Box 54, 3201 Sandefjord, Norway. Ugland has recently been acquired by a subsidiary of Teekay Shipping Corp. (NYSE: TK), a publicly traded shipping company headquartered in Nassau, Bahamas. Ugland continues to operate independently.

The Reporting Person has not, during the last five years, been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors). None of the Reporting Persons has, during the last five years, been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction which resulted in a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to federal or state securities laws or finding any violations with respect to such laws.

Herbjorn Hansson is a citizen of Norway.

### Item 3. Source and Amount of Funds or Other Consideration

As of the date hereof, Ugland owns 1,150,221 Shares.

### Item 4. Purpose of Transactions

The Shares acquired by the Reporting Person were acquired for, and were sold for, investment purposes. The Reporting Person has no plan or proposal which relates to, or would result in, any of the actions enumerated in Item 4 of the instructions to Schedule 13D.

### Item 5. Interest in Securities of Issuer

As of the date hereof, Ugland owns, 1,150,221 Shares. As of the date hereof, there were 9,706,606 Shares outstanding. Therefore, Ugland owns 11.85% of the outstanding Shares. The Reporting Person has the sole power to vote, direct the vote, dispose of or direct the disposition of all the Shares that it owns. All transactions in the Shares effected by the Reporting Person since the most recent filing on Schedule 13D were effected in open-market transactions and are set forth in Exhibit 1.
