(iii) MCM, Mr. Maltese may be deemed to beneficially own an additional 841,737 shares of Common Stock held of record by certain clients of MCM, constituting, in the aggregate, beneficial ownership of 861,955 shares of Common Stock and approximately 7.06% of the shares outstanding.
