A total of 79,464 shares are beneficially owned by Dr. Brody; 48,400 are held jointly with his spouse; 12,705 are held in street name; and 18,359 are held in an account at Computershare.

- (4) Dr. Brody exercised 2,200 stock options at \$3.46 per share, and sold at \$23.00 per share.
- (5) 13,600 stock options were granted of which 7,867 are currently exercisable.
