The Annual Meeting of Stockholders of the Company was held on November 21, 2016. The matters listed below were submitted to a vote of the stockholders through the solicitation of proxies, and the proposals are described in detail in the proxy statement filed with the Securities and Exchange Commission on October 11, 2016 (the "Proxy Statement"). Of the 4,004,061 shares outstanding and entitled to vote, 3,744,735 were present at the meeting in person or by proxy. The final results of the stockholder vote are as follows:

1. The election of three directors of the Company, to serve for three-year terms and until their successors are elected and qualified.
