**Item 1.01 Entry into a Material Definitive Agreement**

On June 7, 2006, Royal Caribbean Cruises Ltd. entered into an underwriting agreement with Goldman, Sachs & Co., Barclays Capital Inc., BNP Paribas Securities Corp., Greenwich Capital Markets, Inc., Morgan Stanley & Co. Incorporated, DnB NOR Markets, Inc., J.P. Morgan Securities Inc., Morgan Keegan & Company, Inc. and Scotia Capital (USA) Inc., as underwriters, with respect to the offer and sale of \$550,000,000 principal amount of its 7.00% Senior Notes due 2013 and \$350,000,000 principal amount of its 7.25% Senior Notes due 2016, pursuant to its Registration Statement on Form S-1, File No. 333-115090. The form of underwriting agreement is attached hereto as Exhibit 99.1 and is incorporated by reference into such Registration Statement.
