(1) Represents rights to purchase common stock under a warrant entitling Morgan Stanley Wind LLC ("MS Wind") to purchase up to 8% of the common stock of Distributed Energy Systems Corp. ("DESC") on a fully diluted basis from time to time, including shares of common stock issuable upon the exercise of stock options, warrants and other convertible or exchangeable securities. MS Wind is not entitled to exercise the warrant if immediately following such exercise MS Wind's beneficial ownership (as calculated pursuant to Rule 13d-3) would exceed 19.9% of the outstanding shares of DESC. The expiration date of the warrant is March 7, 2009 unless the fair market value of the common stock on that date is below a certain threshold in which case the expiration date will be extended out until March 7, 2010.
