<b>Underlyings:</b>	S&P 500® Index and Russell 2000® Index
<b>Pricing date:</b>	November 30, 2018
<b>Valuation dates:</b>	February 28, 2019, May 30, 2019, August 30, 2019, December 2, 2019, March 2, 2020 and June 1, 2020 (the “final valuation date”)
<b>Maturity date:</b>	June 4, 2020
<b>Contingent coupon payment dates:</b>	The fifth business day after each valuation date, except that the contingent coupon payment date following the final valuation date will be the maturity date
<b>Contingent coupon:</b>	2.00% to 2.25% per quarter (8.00% to 9.00% per annum)*, <b>only if</b> the closing value of the worst performing underlying on the immediately preceding valuation date is greater than or equal to its coupon barrier value. <b>You are not assured of receiving any contingent coupon payments on the securities.</b>
<b>Automatic early redemption:</b>	If the closing value of the worst performing underlying on any potential autocall date is greater than or equal to its initial underlying value, the securities will be automatically redeemed on the immediately following contingent coupon payment date for an amount equal to the stated principal amount <i>plus</i> the related contingent coupon payment.
<b>Potential autocall dates:</b>	Each valuation date beginning in May 2019 and ending in March 2020
<b>Coupon barrier / knock-in value:</b>	For each underlying, 70% of its initial underlying value
<b>Payment at maturity (if the securities are not earlier automatically redeemed):</b>	If the securities are not automatically redeemed prior to maturity, you will receive at maturity for each security you then hold (in addition to the final contingent coupon payment, if applicable):  If the closing value of the worst performing underlying on the final valuation date is <b>greater than or equal to</b> its initial underlying value:  \$1,000

If the closing value of the worst performing underlying on the final valuation date is **less than** its initial underlying value and a knock-in event **has not** occurred:

\$1,000

If the closing value of the worst performing underlying on the final valuation date is **less than** its initial underlying value and a knock-in event **has** occurred:

$\$1,000 + (\$1,000 \times \text{the underlying return of the worst performing underlying on the final valuation date})$

**If the securities are not automatically redeemed prior to maturity, the closing value of the worst performing underlying on the final valuation date is less than its initial underlying value and a knock-in event has occurred, you will receive less than the stated principal amount of your securities, and possibly nothing, at maturity.**

Worst performing underlying:	For any valuation date, the underlying with the lowest underlying return determined as of that valuation date
Knock-in event:	A knock-in event will occur if, on any scheduled trading day during the observation period, the closing value of any underlying is less than its knock-in value
Observation period:	The period from but excluding the pricing date to and including the final valuation date

### **Selected Risk Considerations**

- You may lose a significant portion or all of your investment. Unlike conventional debt securities, the securities do not provide for the repayment of the stated principal amount at maturity in all circumstances. If the securities are not automatically redeemed prior to maturity, your payment at maturity will depend on the closing value of the worst performing underlying on the final valuation date. If the closing value of the worst performing underlying on the final valuation date is less than its initial underlying value and a knock-in event has occurred, meaning the closing value of at least one of the underlyings was less than its knock-in value on at least one scheduled trading day during the period from but excluding the pricing date to and including the final valuation date, you will lose 1% of the stated principal amount of the securities for every 1% by which the worst performing underlying has declined from its initial underlying value. There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.
- You will not receive any contingent coupon on the contingent coupon payment date following any valuation date on which the closing value of the worst performing underlying on that valuation date is less than its coupon barrier value.
