<b>Contingent coupon:</b>	At least 3.5625% per quarter (at least 14.25% per annum)*, <b>only if</b> the closing value of the underlying on the immediately preceding valuation date is greater than or equal to the coupon barrier value. <b>You are not assured of receiving any contingent coupon payments on the securities.</b>
<b>Contingent coupon payment dates:</b>	The fifth business day after each valuation date, except that the contingent coupon payment date following the final valuation date will be the maturity date.
<b>Automatic early redemption:</b>	If, on any potential autocall date, the closing value of the underlying is greater than or equal to the initial underlying value, each security you then hold will be automatically called on that potential autocall date for redemption on the immediately following contingent coupon payment date for an amount in cash equal to \$1,000 <i>plus</i> the related contingent coupon payment. <b>The automatic early redemption feature may significantly limit your potential return on the securities.
